## Not too late to apply to become a Beccles Town Councillor



Town Council Chambers—  
Mayoral Seat

There is still time for you to enquire about becoming a Councillor for Beccles. In the four wards, Rigbourne, Centre, Common and Darby there will be 16 seats (4 in each ward) up for re-election, and as long as you fill the necessary requirements ie; you must be 18 years of age on the day of nomination. You must reside in the area you wish to stand OR own property or land within the area you wish to stand OR work in the area you wish to stand

OR live within 3 miles (as the crow flies) of the Parish Ward; you need to have your nomination signed by 2 people who are on the electoral register in the ward you wish to contest and you need to be a British subject, or an Irish Republic or European Union citizen living in the UK.

You should consider that being a Councillor is not a short-term occupation as it involves attending meetings, sometimes have to make difficult decisions sometimes, and allowing those who voted you in listening time. You will be elected for 4 years and are expected to take on certain responsibilities on committees or working parties.

A Notice of Election will be published in March on Parish notice boards and on the Councils' websites, giving the information required regarding application.

## ISSUES WHICH COULD SPOIL YOUR ENJOYMENT OF BECCLES COMMON

**Rabbit, Rabbit, Rabbit!** These cute little creatures are slowly eroding the common from underneath and need to be dealt with in the near future. The Town Council are currently considering ways and means to cull the rabbits which are causing mayhem both on the Common and the allotments.

**Cars!** Over the Winter months cars have been having a great time speeding over the Common causing damage by skidding and possibly driving dangerously. The driving of vehicles on the Common is an offence unless authorised by the Town Council. The Police have been informed and cul-

prits will be dealt with accordingly.

**Damage to Greens!** Some people seem to enjoy damaging the greens cared for by Beccles Golf Club. The greens are the best kept in the County and it is a pity that some do not appreciate the time and effort the Green Keeper puts in keeping them at this very high standard. Currently someone is making 'heel marks' around the pins on these greens. The Council have been advised of a suspect and therefore the Police have been informed and a close eye is being kept. If the perpetrator is seen, proceedings against him will follow.

**Damage to Trees!** Someone is entering The Common from the bypass and cutting branches from the trees and taking them away, presumably for firewood. They are causing environmental damage and are guilty of theft. The Police have been made aware of this and are keeping the area under surveillance. Can we ask all Common users to keep their eyes open and report the vehicle registration number to the Police. The Council will prosecute the person when they are caught! If you have witnessed anyone acting irresponsibly on the Common, please contact the Safer Neighbourhood Team on 01473 613500.

## BECCLES FENLAND CHARITY TRUST

Beccles Town Council is the registered owner, on behalf of the citizens of Beccles, of some 746 acres of land. This land brings in an annual income in excess of £30,000 and forms approximately one third of the income of the Town Council. Each year the Council spends some £60,000 on various local expenditure described as being for 'public benefit'.

The Town Council received a letter from the Charity Commission (CC) at the end of November 2008 indicating that the above land was deemed to be charity land and therefore should be registered as such with the CC. It appears that the land was granted under a Royal Charter issued in 1605 during the reign of James I. The Council responded indicating that they needed to do extensive research and would require advice.

In February 2009, two representatives from the CC visited the Council and a complex and prolonged discussion took place,

clarifying some aspects, but leaving many issues unanswered. Both parties agreed that further research would be required. The Town Council agreed to set up a Working Party to explore the various issues.

The Working Party met for some eleven occasions over the next fifteen months. In May 2010, the Chairman of the Working Party travelled to London to meet a representative of the CC, who was extremely helpful and indicated that he could see no reason why the Town Council should not be recognized as the Sole Trustee of the charity.

The next task was to draw up the Governing Document, which would in reality be the constitution of the charity. This task took several meetings, but eventually a draft was forwarded to the CC for their opinion of its accuracy and coverage. A prolonged period followed as the document was forwarded to the legal department of the CC for their opinion. It emerged from

this research that the Charter granted in 1605 was recognized as a Governing Document and this meant the Town Council would be required to draw up the "byelaws" under which the Charity would operate. The Working Party then went ahead and drew up the required "byelaws" which were approved by the CC.

The next step was for the full Town Council to approve and adopt the "byelaws". A special meeting was held on Monday 24th January to put this proposal before Council to which the public were invited, where the proposal to adopt the "byelaws" were discussed and approved.

The next stage was to register the Beccles Fenland Charity Trust with the CC.

It is the hope of the Town Council that all the final details will be completed by 31st March 2011 thus allowing the related accounting procedure to commence in the new financial year.

**THE FUTURE OF BECCLES LIBRARY**

**BECCLES—THE PRESENT AND THE FUTURE

Beccles Town Council, through the efforts of the then Town Clerk, Mrs B Broom, achieved Quality Parish Status in 2010. Whilst this does not bring finance into the town, it gives kudos with other councils and larger organisations. The duties of a Town Clerk and staff are not always cut and dried, nor is the work dull. We act as directory enquiries when people can't find telephone numbers, guides for hotels and B&Bs, unofficial map readers and restaurant critics, finders of lost relatives, town guides and general fountains of all knowledge of Beccles and beyond! The Town Clerk is also responsible for preparing the accounts for the Beccles & District Regeneration Ltd and dealing with any legalities of the Charity Commission in relation to it. The Diamond Jubilee Aid in Sickness Fund is also clerked by the Town Clerk who deals with all the formalities, the accounts. About half of the funding for administering council functions comes from the precept, which is

a tax on the residents of Beccles through Waveney District Council. The rest of the funding comes from land and property rents, bank interest and dividends, although this last revenue has fallen over the last year. Council uses the funds for administration and salaries, maintenance of the Common, The Avenue, the marsh pump (+ electricity charges), the dykes and marshes, the skateboard park and supply grants to local organisations. All expenditure has to be budgeted for and is approved by full council before anything is spent. The Marsh Trail is maintained, as is the Town Hall and other properties, including the Christmas Lights together with a grant to the Christmas Late Night Shopping event.

The Pride in Beccles team benefits from funds to enable enhancements to the Town, such as the shelter refurbishment and the five new town signs, the first of which was first instigated by Dr Wood-Hill who was Mayor of

the Borough of Beccles from 1935 to 1938. He was the only Mayor who was ever elected and was not elected as a Councillor.

'Mr Tidy' is funded through the Council with help from some organisations and businesses. His role is to keep the town centre clean and weed-free. Since being employed by the Council he has attained a spraying certificate in the safe use of pesticides. Although his role is primarily in the town centre, he can often be seen following requests, clearing and cleaning other areas of the town where Waveney do not fulfill their obligations.

As you may have guessed from one or two comments, the Town Council does not always see eye to eye with the District Council. The Town Council feels that Waveney has neglected its duties in the town, especially with regard to property it took over in 1974, eg the outdoor pool, the public hall, the Quay, etc. Relationships have improved some-

what over the last year or so, but the Town Council still feels that the District Council pay lip service somewhat. Quarterly meetings between the Town Clerk/ Deputy Town Clerk and the Chief Executive Officer of Waveney and other Officers to discuss problems which Council feels need addressing help, to some extent, and Clerks from other local Parishes also attend these meetings, so it is a step forward for communication.

**FUTURE—** Hopes for the future—who knows what that holds. The Boundary Commission and the Local Government Review were all for removing Waveney from the bosom of Suffolk and moving it to Norfolk. Other Councils were up in arms about the diverse suggestions of boundaries. Everyone had an interest and everyone was informed, costing Councils hundreds of thousands of pounds for all the research.
